

## Release Notes for ROSETTA *Phoenix* Desktop R5.3.1 Build 1095

**Date: April 24, 2017**

This Release Notes lists new features, changes, bug fixes that are implemented in R5.3.1 since the release of R5.2 as well as known issues.

### System Requirements and Supported Configurations

- Microsoft Windows 7 (32-bit and 64-bit), Windows 8.x (64-bit), Windows 10 (64-bit) and Windows Server 2012 (64-bit, as a Citrix host)
- Microsoft Internet Explorer 9, 10 or 11
- Recommended RAM: 2GB or more

22701	Adds support for pilot testing of the Thailand eCTD M1 specifications v0.91
22405	Supports the ability to view the South Africa (ZA) eCTD M1 specifications v2.1.

### Change:

CR#	Description
21825	Removes the Save feature from the embedded PDF reader to prevent accidental overwrites of PDF files even if the security setting on the files does not prevent them.

### Bug Fixes:

23494 22428	The Link Appearance is not displayed as defined in scanned PDF documents.
23453	Consumer Promotional Material information does not display in the report window.
22792 23297 23342	Supports mixed US DTD versions in one eCTD application: <ul style="list-style-type: none"> <li>• Filter Settings do not correctly filter the TOC.</li> <li>• For sections whose name is changed between DTD versions, Desktop erroneously displays the lower DTD version's name.</li> <li>• Hyperlinks in eCTD applications with folder name containing characters other than 6 digits fail to open the target documents.</li> <li>• ToC Search does not return the correct search results.</li> </ul>
23299	Fixes issues related to mixed CA DTD versions in one eCTD application: <ul style="list-style-type: none"> <li>• Section names are not sorted correctly in TOC view and Filter Settings window.</li> <li>• The section m1-2-5-7 is not displayed correctly.</li> <li>• M1 section names are not displayed correctly.</li> </ul>

23109 23298	Fixes issues related to mixed EU DTD versions in one eCTD application. <ul style="list-style-type: none"> <li>• M1 section names are not displayed correctly.</li> <li>• Metadata is not displayed in Sequence View</li> </ul>
23300	Fixes issues related to mixed CH DTD versions in one eCTD application: <ul style="list-style-type: none"> <li>• Submission Type in TOC Search is not displayed correctly.</li> </ul>
23301	Fixes issues related to mixed ZA DTD versions in one eCTD application: <ul style="list-style-type: none"> <li>• The “Submission type(s) to display” field in the Filter Settings window does not filter correctly.</li> </ul>
23068	An Access Violation error occurs when opening a sequence with comments at the first element in its index.xml.
23253	For TH v0.91, v0.92, v1.0, related sequences do not display correctly in Regulatory Activity View.
23308	An Access Violation error occurs when loading documents with certain PDF objects.
23015	A linked replaced or deleted file does not open correctly with the “Open in new window” option.
22825	The “Sort documents by document title” option under “Ordering of documents within TOC sections” does not sort correctly.
22358	Clicking on a bookmark that points to an external document does not open the target document.
22364	“Node” displays under sections of Module 4 or Module 5 when the STF xml file defined in the eCTD backbone does not exist.
22135	Cannot open the target MS Word/Excel document after following an external PDF link when the document is already opened from Phoenix Desktop.
22699	Some metadata elements are missing when Japanese eCTD submissions were viewed in the Sequence View.
22700	An access violation error occurs when loading the Regulatory Activity View of a mixed DTD version EU eCTD application.

**Known Issues:**

CR#	Description
23514	The validation functionality of the XML files against the DTD fails to retrieve the us-regional-v3-3.dtd, at <a href="http://www.accessdata.fda.gov/static/eCTD/us-regional-v3-3.dtd">http://www.accessdata.fda.gov/static/eCTD/us-regional-v3-3.dtd</a> and displays an “Access is denied” message. (This error does not affect other functions of the application except XML validation.)
23148	An Access Violation error occurs when following a specific bookmark to an external document in the same tab.
23143	An empty error message box appears when interacting with a document with annotations after editing and reopening it.
22414 22459	An access violation error occurs after a few times of Back or Forward operations when opened the target document in the same tab from within external bookmarks.

<b>CR#</b>	<b>Description</b>
22091	There is no option for an end user to view the more recent document if the target document is replaced or deleted when following links in a document from within a new window.
<b>Carried over from earlier versions prior to R5.2</b>	
18915	Some tool buttons of the embedded PDF Reader are not accessible if there is not enough viewing space for the Document View Panel.
18773	A PDF document's bookmark panel is collapsed in the embedded PDF Reader even if the PDF setting states to keep it expanded by default (A Foxit PDF Reader limitation).
18061	There is no vertical scroll bar for the Regulatory Activity View even if the view is crowded with many activities.
16763	The mouse wheel doesn't work on Search Results Pane within Phoenix Desktop.
